Requirements

- » Dogs that have passed a F A test and want to qualify for a F B test.
- » Only one dog per handler
- » Dog handlers will be used as helpers
- » Proof of all vaccinations according to IRO vaccination scheme (leptospirosis, parvovirose, distemper, hepatitis and rabies) for the dog; the trainer has to check the dog's vaccination status, in case it does not correspond to the IRO vaccination scheme, the dog is not allowed to participate in the course
- » Valid insurance and required vaccinations for the dog for travelling into and staying in the Czech Republic.
- » The taking along and use of means of force are prohibited.
- » The Austrian Animal Welfare Act applies.

The number of participants is limited to 24 rescue dog teams. Registration in order of date of receipt (postmark).
